Introduction

The **eChallenges e-2006** Conference takes place in the beautiful city of Barcelona. This is the sixteenth in a series of Annual Conferences supported by the European Commission, which regularly attracts over 550 delegates from leading commercial, government & research organisations around the world to share knowledge and experience, lessons learnt and good practice.

The goals of the eChallenges Conference Series are to stimulate take-up of RTD results by industry - in particular SMEs - as well as the European public sector, to promote knowledge sharing between commercial organizations, government agencies and the research community, to exchange experiences about the current state of eAdoption at a sectoral, national or regional level, support International Cooperation and open up the European Research Area (ERA) to the rest of the world.

eChallenges e-2006 will focus on topics in the area of applied Information Society Technologies (IST) research, addressing major societal and economic challenges. The programme combines strategic keynote presentations, technical and policy papers, business and government case studies, workshops, the exhibition as well as social activities.

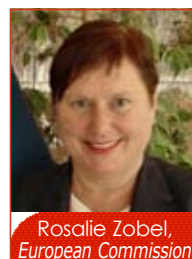

Submission of Abstracts

Extended abstracts are invited for **e-2006**. The conference language is English and abstracts should be for technical papers, business/government case studies or visionary papers within the scope of the conference. **Extended abstracts of 1,000 - 1,200 words** must be registered on the conference portal (www.eChallenges.org) by **28th February**.

Your abstract should provide a clear overview of your proposed paper using the following headings:

- Introduction - Issues to be addressed
- Objectives of your paper
- Methodology Used
- Technology or Business Case Description
- Conclusions and Summary Recommendations

It should **focus on a research topic** on which either a case study, initial or final results can be published. All papers must **highlight the level of innovation**. General project descriptions are not appropriate. Criteria for proposals for workshop sessions are provided on www.eChallenges.org.

Papers or sessions can take the form of:

- Presentation of innovative ICT achievements
- Discussion of current status of eAdoption in a specific industry sector, country or region
- Lessons learnt - business/government case studies
- Lessons learnt from regional and national programmes and initiatives
- Discussion of ERA or International Cooperation oriented issues
- Discussion of existing and emerging standards
- Discussion of future oriented technologies
- Discussion of existing and emerging standards
- Discussion of IPR, legal and contractual issues

Papers and workshops are subject to acceptance at both stages of the double blind peer review process. Final papers and workshop sessions are also subject to editorial review and a quality check.

It is a condition of submitting an abstract that (a) authors act on feedback and comments provided by the International Programme Committee (IPC) to ensure high quality conference proceedings, (b) presenters act on feedback provided by their Session Chair to ensure high quality presentations, and (c) presenters register and pay the participant's fee by 30th June, before the papers are sent to the publisher.

- Paper abstracts, workshop and tutorial proposals submitted by **28th February 2006**
- Provisional acceptance by **31st March**
- Draft papers submitted by **30th April**
- Provisional acceptance of draft papers with IPC feedback provided by **31st May**
- Final papers to be delivered electronically by **30th June** for editorial review and quality check

Conference Proceedings

The **e-2005** conference proceedings were published in CD-ROM format. "Innovation and the Knowledge Economy – Issues, Applications, Case Studies", an accompanying 2-volume book was published by IOS Press. Each delegate received a free copy of the book and conference proceedings at Registration.
